Spirit Ambassador Competition**

Dear Utah Job's Daughters,

It is time to start thinking about the Spirit Ambassador Competition! This year we are encouraging **ALL eligible Daughters** to try out. It is a fun growing experience, you meet great people, and make lifelong friends!

The all-in-one day pageant and competition will be held on Saturday, September 15th, 2018 beginning at 8:30 A.M. We will begin with the usual competition, which includes a written test, personal interview, a ritual recitation, and robe judging. After a break for a few hours in the afternoon, we will have the banquet, final pageant and announcement of the 2018-2019 Spirit Ambassadors and the crowning of the 2018-2019 Miss Utah Job's Daughter and Miss Utah Congeniality.

Eligibility

Any Job's Daughter, under the age of sixteen (16) at the time of the Utah Competition on September 15th, 2018, who has passed proficiency and is in good standing in her Bethel, is eligible to compete.

Written Test

The written test will cover only the Ritual (Revised 2011). We suggest to study the Ritual a cover-to-cover.

Ritual Recitation

Spirit Ambassador Contestants must recite the Obligation. This recitation may be done with or without pauses. However, if pauses are used they must be in the right places. Please note: this will be the Proficiency Lessons (2011).

Entry Form and Fee

Entry form must be filled out with entry fee and postmarked (or hand delivered) by Sunday, August 19th, 2018. Contestants can hand deliver their forms to Nicole Bronson at Field Day to be held on August 19th, 2018. The entry fee for this year's competition will be \$15.00. All competitors will receive a complimentary banquet dinner ticket. Check for entry fees should be made payable to the Grand Guardian Council. Please note financial assistance is available if the registration fee is an issue.

Personal Health Form

All Daughters who are participating in the Spirit Ambassador Competition must submit an original copy of a Job's Daughters International Personal Health Form. This form is needed incase an emergency were to arise at the pageant sleepover or any events that may occur during the course of the year if selected as a Utah Spirit Ambassador. Health forms will be held by the official chaperone of the Utah Spirit Ambassadors for the course of their year in office. Health forms must be submitted by the date of the pageant sleepover for Daughters to spend the night without their parent's accompaniment.

Mark your calendar for the Pageant Contestant Sleepover on August 25th, 2018 at 6:30 P.M. at the Bountiful Masonic Temple.
